



- 25 one-on-one meetings during January 24-30



Comments on Specific Locations



Location	Comment		
Rosedale Transit Center	 Would like the Park-and-Ride back at Rosedale. 		
Snelling & County Rd B	•Target needs to make a sidewalk to the Har Mar bus stop.		
Snelling & Roselawn	Almost nobody uses this stop.		
Hamline & Larpenteur	 An 84 route option to serve as much of Hamline as possible would be a good idea (a la future Route 83). 		
Hamline & Hoyt	 Consider restoring the 84 Local to the Hamline/Hoyt area! 		
Snelling & Nebraska	 Can you add a stop between Larpenteur and Como, even with the limitation of the west side boundary of the State Fair? Job Corps span of service later at night. Need stop in the Como-Larpenteur gap! 		
Snelling & Como	 A dedicated bike lane is needed along Snelling between Como and Hewitt (similar to bike bridge along Lexington). 		
Snelling & University	• The bus stop by the book store is too small for such a high usage.


CONCEPT 2 - "GUST"


