Terms and Conditions for Young Adult 10-Ride SuperSavers

Please read the following important information as it pertains to the distribution of Young Adult 10-Ride SuperSavers through your organization and your responsibilities as an organization supplying these cards.

Young Adult Responsibility

- Young Adults must take care of their cards. Cards cannot be laminated, hole punched, stapled, washed, crumpled, etc. They should also be kept away from heat or magnetic sources.
- Damaged cards will not be accepted for fare payment.
- Lost or stolen cards can not be replaced.
- Young Adult Cards will not be accepted for exchange or return by Metro Transit stores or outlets Young Adults must return unused cards to the organization from they were issued/purchased. The authorized school or employer will then take action for exchange through Metro Transit Sales Operations.

Organization Responsibility

- The organization (e.g. employer or school) is responsible for monitoring abuse or overuse of Young Adult SuperSavers.
- It is the choice of the organization whether it will sell fare cards to young adults or distribute them free of charge.
- If the organization chooses to sell Young Adult SuperSavers to young adults ages 17 and under, it will be required to sell them at a cost of \$13.50 or less.
