After five years of leading the Gold Line project team, Chris Beckwith is leaving the project director position to take on the role of Blue Line Extension project director. We want to recognize and thank Chris for all her work and leadership to move the Gold Line project through final environmental review and project design and prepare for construction.

We also want to give a warm welcome to Alicia Vap who will serve as the interim Gold Line project director. Alicia has worked at Metro Transit for 14 years and most recently as a representative from Metro Transit's Engineering and Facilities office on transit projects including Gold Line. Alicia also has a wealth of experience as a project manager from working on the Orange Line BRT, Blue Line Extension, and Green Line projects.

**Construction updates****Public utility work underway**

In April, public utility crews began working in the project area to update overhead and underground utilities ahead of Gold Line construction starting this fall. Preparations include:

- Replacing utility cabinets, poles, and foundations
- Replacing and relocating underground power and communication cables

Drivers in the area may encounter temporary road, lane and shoulder closures on I-94, I-494, and I-694. Utility crews will continue work through the summer to prepare the project corridor for construction.

**Private utilities begin work**

Xcel Energy recently began its utility relocations in downtown St. Paul ahead of Gold Line construction. Through mid-July, Xcel Energy crews are relocating gas pipes on 5th Street, between Robert and Jackson streets. Crews will move to 6th Street once this work is completed. People walking, biking, rolling, and driving in the area may encounter sidewalk closures, on-street parking restrictions, and lane closures.
