Rider's Almanac


Take a behind-the-scenes look at Metro Transit

Go-To *lite* Cards: Another easy way to pay fares

If you have clients or employees who will be using transit for a limited time period, consider Go-To *lite* Cards.

Go-To *lite* Cards work just like Go-To Cards, but are thrown away after their use.

Because these cards are designed to be thrown away, customers should not register or add value to them. Lost or stolen Go-To *lite* Cards cannot be refunded or replaced.

These Go-To lite Cards are available:

- 10-Ride for adults
- 10-Ride for students (k-12)
- 31-Day Passes (\$85 or \$113.50)

Note: The \$85 and \$113.50 SuperSaver 31-Day Passes are no longer available for sale.

Transit tax benefit increased

In case you missed it: The financial incentive for commuters to take transit got bigger this year.

Under the fiscal cliff legislation approved by Congress, commuters who ride the bus or train or use vanpools to get to work are eligible for up to \$245 per month in a pre-tax transit benefit.

Previously, the commuting costs that transit customers could claim as tax deductible had been reduced to a maximum of \$125 per month, well below the \$240 that car commuters could claim to offset monthly parking costs.

The new level for the federal transit tax benefit is only temporary and will expire at the end of 2013 unless Congress extends it.
