Txojkev khiav tshiab no yuav los hloov txoj qub kev khiav rau Npav 852 thiab yuav nthuav kev thauj neeg ntxiv rau sab qab teb dhau I-694 raws txojkev East River Rd. hauv Fridley thiab raws txojkev Marshall St. hauv Northeast Minneapolis, qhov yuav ua kom txojkev khiav thauj tau neeg zoo tuaj yog ua kom yoojyim rau neeg caij thiab kom neeg tso siab tau rau nyob rau lub nroog sab qaum teb.
